#### **ROAM Project (May 2014 – March 2014)**

EnAbling Change Program in partnership with Council of Ontario Universities (COU)

#### aims to

- •Provide libraries with information they need to consider their options for making multimedia collections accessible (workflows + Directory of service providers)
- •Highlight pertinent sections of the AODA + Canadian Copyright law and share a list of questions to take to your own institution's legal counsel
- assist Ontario Universities in becoming AODA compliant and serving students and faculty most effectively



## building a community of practice

#### technology: access to information

better expertise and knowledge to know how to create better learning environments. All staff need to develop basic accessibility competencies to know how to support our researchers, faculty and students. Moving away from the medical model and towards social justice – disability is not something that needs to be fixed.

user needs: Needs get framed as "special" – design needs to accommodate everyone. Accessible resources make **better learning materials** for everyone!

partnerships: **partnering** with cultural centres and programming across the campus so disabled and non-disabled students see disability presented in all programs offered on campus + resources could be **Shared** to develop more inclusive learning environments.



## next steps

- Awareness phase to help us disseminate the knowledge we gathered
- Assessment phase how do schools that have not provided accessible media services plan to move forward? What about schools that have been doing this – will they need to standardize approaches with other institutions?
- What can we do collaboratively to reduce costs and ensure consistency?

## Improving Accessibility of Libraries and Archives: Potential Solutions

- Human resources
  - Assistants to work with students with disabilities

- Technological solutions
- Provision of library space orientations to students in need

# Improving Accessibility of Libraries and Archives: Thought Frame

- Through a rational deconstruction of the environment, what are the issues likely to arise for the student?
- What are the student's "use requirements" of the library/archive environment?
- What barriers exist to the use of the space/resources for students with disabilities?
- What lessons by analogy can be applied from other environments?
- Will a library assistant be a feasible solution?
- What mainstream technology can be adapted as an accommodation aid?
- What potential solutions can be evolved from experience and analogy that may be workable for the student?



## National Graduate Experience Taskforce: Statement of Need

 There is a significant need to better understand the overall experiences of disabled students in graduate studies

- Currently, there is a critical lack of information in this area
  - Need to understand the "student experience tapestry"
  - Need to catalogue institutional leading practices



## National Graduate Experience Taskforce: Approach and Mandate

 Establishment of a large, multi-stakeholder group of subject matter experts (National Graduate Experience Taskforce)

 Mandate: To review and discuss the academic experience of graduate students with disabilities, in the context of the last fifteen years' advances in technology, attitudes and legislation

- To develop a discussion paper outlining the current system issues for graduate students with disabilities
- To produce information and develop strategies to facilitate the success of students with disabilities in graduate programs

- To develop recommendations for the continued improvement of graduate experience for students with disabilities, that can be translated into policy at an institutional, provincial, or national level
- Long term: To develop "toolbased" approaches for students, faculty and institutions to use in addressing issues faced by graduate students with disabilities
